### Plain English Summary

- This service is provided as-is. We are not liable for document errors or data loss.

### 1. Acceptance of Terms

By accessing or using SimplifiedPDF (the "Service"), you agree to be bound by these Terms and Conditions ("Terms"). If you do not agree to these Terms, please do not use the Service.

These Terms apply to all users of the Service, including users who access the Service without creating an account.

### 2. Description of Service

SimplifiedPDF is a browser-based PDF editing tool that allows you to:

- Add and edit text on PDF documents
- Create, save, and apply signatures to PDF documents
- Store PDF documents locally in your browser
- Download modified PDF documents to your device

**All document processing is performed entirely within your browser. Your documents are never transmitted to, or stored on, our servers.**

### 3. Privacy and Data

#### 3.1 Document Privacy

SimplifiedPDF processes all PDF documents locally within your browser using client-side technology. We do not upload, transmit, access, view, store, or retain any documents, signatures, or content that you edit using the Service. Your files remain on your device at all times.

#### 3.2 Local Storage

Documents and signatures you choose to save are stored in your browser's local storage (IndexedDB). This data exists only on your device. Clearing your browser data will permanently delete this stored information. We recommend downloading edited documents to your device to avoid loss.

### 3.3 Account Data

If you choose to create an account, we collect your email address and authentication credentials. This data is stored securely and used solely for account management and to verify donor status. We do not sell your personal data to third parties.

### 3.4 Usage Analytics

We may collect anonymised, aggregate usage data (such as page visits and feature usage counts) to improve the Service. This data cannot be used to identify you or access your documents.

## 4. Free Use and Donations

The core features of SimplifiedPDF — including editing, signing, and downloading documents — are free to use and will remain free. There is no paywall on downloads, no trial period, and no subscription required to access core functionality.

We may offer an optional donation to support ongoing development. Users who donate may receive benefits such as an ad-free experience. Donations are voluntary and do not affect your access to core features.

## 5. Advertising

The Service may display third-party advertisements to support ongoing development and hosting costs. Advertisements will not be shown within the document editing interface. Users who have donated and hold an active account may be eligible for an ad-free experience.

We will never serve ads that are based on the content of your documents, as we have no access to them.

You agree not to use the Service to:
